## Overview

**Jurisdiction:** Wyoming, USA.

**Formation time:** less than 24 hours.

**Number of members required:** 1 member minimum.

**Manager:** The LLC can be Member Managed or Manager Managed

**Registered Address and Agent:** required within the State of Wyoming.

**Estimated time to receive EIN for foreigners:** 1-2 weeks.

## Taxation & Compliance

### State Level

**Income Tax:** LLCs are not taxed at a State Level provided they do not engage in business or trade in Wyoming, and do not have Wyoming sourced income.

**Annual Report:** due on the first day of the anniversary month of formation. The State annual report fee is US\$60 provided there are no assets located in Wyoming.

Information reported in the Annual Report:

- Registered Address and Agent.
- Manager of the LLC.
- Assets Located in Wyoming.


### Federal level

#### Income Tax

**Foreign Owned U.S. DE:** If the LLC is owned by one foreign member, it will be treated as a Foreign Owned U.S. Disregarded Entity, and will not be subject to income tax provided it did not engage in Business or Trade in the U.S., and doesn't have U.S. Sourced or Effectively Connected Income (ECI)

**Filing requirements for Foreign Owned U.S. DE:** Form 1120 (Pro Forma) and Form 5472 if the LLC had any reportable transaction between the LLC and the Owner.

**Multi-Member:** LLCs owned more than 1 member are taxed as a Partnership, and have to file form 1069.

## Banking:

Can open U.S. bank accounts and Offshore Bank Accounts. High privacy, no CRS. Access to Payment gateways such as Stripe and PayPal.



## Asset Protection:

Can be used to acquire any type of property, from Real Estate, to gold, yachts, etc, in the U.S. and in other parts of the world.

## Low tax and compliance

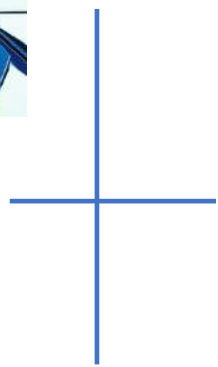
No tax if owned by one foreign member and not engaged in U.S. Trade
